WHAT DOES FS FINANCIAL, INC. DO WITH YOUR PERSONAL INFORMATION?

WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. WHAT?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social security number Income and other information from applications Account balances and payment history Transaction history and credit history
HOW?	All financial companies need to share customer's personal information to run their everyday business. What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Affiliates	Companies related by common ownership or control. They can be financial and non financial companies: Our affiliates include our branches doing business as First Southern Financial.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.

Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
